# **Preventive Pharmacy Services**

The following is a list of preventive services that PHP has determined meet, and in some cases exceed, the requirements and recommendations issued by the Affordable Care Act (ACA).

The ACA requires that non-grandfathered\* health plans cover preventive care services with no cost sharing. A prescription is required for over-the-counter (OTC) products to be covered with no cost share. Prescriptions must be obtained at an in-network pharmacy. This list is subject to change.

#### Adults

Prevention of cardiovascular disease and colorectal cancer aspirin 81 mg (OTC, generic) for adults age 50-59 Colorectal Cancer Screening Adults age 50-75 are covered for the following generic formulations of the prescription and OTC bowel prep products:

Bisacodyl 5 mg oral tablet	Polyethylene glycol (PEG) 3350 oral powder	Generics to GaviLyte-N or Nulytely (PEG 3350, KCI, sodium bicarbonate, NaCl)	Generics to Golytely (PEG 3350, KCI, sodium bicarbonate, NaCl, sodium sulfate)
Magnesium citrate	Polyethylene glycol (PEG) 3350 oral packet	Generics to GaviLyte-C (PEG 3350, KCl, sodium bicarbonate, NaCl, sodium sulfate)	

Tobacco Cessation Chantix®, bupropion, and generic nicotine replacement products (e.g. patches, gum) are covered for up to a 180-day supply in 365 days. Additional quantities require prior authorization.

Statins for Primary Prevention of Cardiovascular Disease Coverage of the following statins for adults 40-70 years:

Atorvastatin 10 mg, 20 mg	Fluvastatin ER 80 mg	Pravastatin 10 mg, 20 mg, 40 mg, 80 mg	Simvastatin 5 mg,

## Women's Health & Pregnancy

Risk Reduction or Primary Breast Cancer Criteria must be met for tamoxifen or raloxifene to be covered without cost share Prevention of Morbidity/Mortality from Pre-eclampsia aspirin 81 mg (OTC, generic) for ages 12-59 years Supplementation with Folic Acid for all women planning or capable of pregnancy supplement folic acid 0.4 - 0.8 mg **Contraceptives** Prescription and OTC medications for women:
